Rally: Ribbons 1<sup>st</sup> through 4<sup>th</sup> place, green Q ribbons for scores  $\geq$  170, dark green Q ribbons for scores  $\geq$  195.

Rosettes: High in Trial, High Scoring Aussie, High Scoring Other Breed, High Scoring Junior, High Combined Score in Excellent B & Masters B. Double High Combined will receive a rosette and special award.
